Introduction

Navigating the legal system without professional representation can be daunting. Reliable information is essential, but for litigants in person, finding trustworthy, up-to-date legal resources can be a challenge.

This guide brings together accessible legal information to help individuals better understand and engage with the legal process. It is organised around key stages: from seeking early legal advice and exploring alternatives to court, to engaging legal representation, considering funding options, and, if necessary, representing yourself.

This guide was created by a law librarian who is familiar with legal materials, though not legally qualified. It is an independent effort, unaffiliated with any organisation or institution, and should not be regarded as legal advice. Rather, it aims to bridge the legal information gap by directing users to helpful resources.

Terminology

There are a number of different terms used to describe someone representing themselves in legal proceedings, these include unrepresented or self-represented person (or party), appellant in person, and the most commonly used - litigant in person.

In 2013, the Master of the Rolls issued a practice note regarding preferred terminology:

"The term 'Litigant in Person (LiP) should continue to be the sole term used to describe individuals who exercise their right to conduct legal proceedings on their own behalf."

- Practice Guidance, 11 March 2013 [2013] 2 All ER 624

1.6 Contacting Your MP

MPs can help with issues which are under Parliament's responsibility, but cannot intervene in court decisions or private disputes. For local matters such as housing, council tax, or consumer issues, it's best to contact your local council or Citizens Advice Bureau in the first instance.

2. Resolving Disputes Without Going to Court

Not all disputes need end in litigation and many can be effectively resolved without going to court. Due to the high costs of legal proceedings, it's wise to consider Alternative Dispute Resolution (ADR) in the first instance.

Alternative Dispute Resolution (ADR), or alternatives to resolving a dispute without going to court, can take the form of arbitration, conciliation, mediation, and ombudsmen (for consumer disputes).

Arbitration is a private dispute resolution process where a neutral arbitrator makes a binding decision based on evidence and arguments from both sides. It offers a legally enforceable outcome without going to court.

2.2 Conciliation

Conciliation is a voluntary process where a neutral third party helps disputing parties reach a mutually acceptable agreement, often by suggesting possible solutions. Unlike mediation, the conciliator may take a more active role in advising.

2.3 Mediation

Mediation is a process facilitated by a neutral third-party (the mediator) who helps parties reach a voluntary and mutually acceptable agreement without imposing a decision. The process is confidential, flexible, and guided by a Mediation Agreement, with parties retaining full control over the outcome.

4.1 Legal Aid

Legal aid is government help to pay for legal advice or representation if you can't afford it. It's available for certain types of cases and depends on your income and the issue involved.

'There have been dramatic reductions in the availability of legal aid in England and Wales since 2012 and these have overwhelmingly affected the poor and people with disabilities, many of whom cannot otherwise afford to challenge benefit denials or reductions and are thus effectively deprived of their human right to a remedy. The LASPO Act (Legal Aid, Sentencing and Punishment of Offenders Act) gutted the scope of cases that are handled, ratcheted up the level of means-tested eligibility criteria, and substituted telephonic for many previously face-to-face advice services.'

4.2 Exceptional Case Funding (ECF)

Exceptional Case Funding (ECF) enables people in England and Wales to receive legal aid for cases not normally covered, provided they cannot afford legal representation and refusing aid would breach their rights under the European Convention on Human Rights or retained EU rights

4.3 Pro Bono

Pro bono is professional legal help given for free by qualified lawyers to people who can't afford it and don't qualify for legal aid. Organisations such as LawWorks and Advocate help connect people with pro bono lawyers.

Advocate

Advocate is a UK charity that connects people, who can't afford legal help and don't qualify for legal aid, with volunteer barristers. Applicants submit a form and case documents and, if eligible, Advocate tries to match them with a barrister for free legal advice or representation, depending on availability. https://weareadvocate.org.uk/apply-for-help/how-our-service-works.html

Free Representation Unit (FRU)

Provides free legal representation for eligible individuals in employment tribunals, benefit appeals and criminal injury compensation cases, but only for hearings taking place in London or the South East, and generally only if the case has been referred through an accredited advice agency. https://www.thefru.org.uk/can-fru-help-you

4.4 Conditional Fee Agreements (CFA) & Damages-Based Agreements (DBA)

'A conditional fee agreement (CFA) is an arrangement under which a lawyer agrees with a client that they will only be paid in specified circumstances (usually where the case ends in 'success' for the client). These are commonly known as 'no win, no fee' agreements.

5. Representing Yourself

If you're unable to obtain legal representation, whether due to financial constraints, eligibility issues, or personal choice, you may decide to represent yourself in court. This is known as being a "litigant in person."

'A litigant in person is an individual, company or organisation who has to go to court without legal representation from a solicitor or barrister.'

They do not have a right of audience, but they can, in exceptional circumstances, be permitted by the judge to speak on behalf of the LIP.'

It is important to read the the relevant procedure rules, such as the CPR for civil cases, because, as emphasised by the Supreme Court in <u>Barton v Wright Hassall LLP [2018] UKSC 12</u>, litigants in person are expected to familiarise themselves with the relevant procedural rules and cannot expect special treatment or exemption from compliance.

"Their lack of representation will often jusitify making allowances in making case management decisions and in conducting hearings. But it will not usually justify applying to litigants in person a lower standard of compliance with rules or orders of the court. The overriding objective requires the courts so far as practicable to enforce compliance with the rules [...] The rules do not in any relevant respect distinguish between represented and unrepresented parties."

11. Generative Al

Generative AI is a type of artificial intelligence that creates new output by learning patterns from existing data. OpenAI's ChatGPT is an example of Generative AI.

Litigants in person must take great care if using Generative AI applications. There are serious risks involved, highlighted by recent High Court rulings, such as <u>Ayinde v London Borough of Haringey [2025] EWHC 1383 (Admin)</u>, where fabricated legal citations, likely generated by AI, resulted in referrals to regulatory bodies and warnings about potential contempt of court.

If you do use Generative AI:

- Avoid relying on it alone. It can be useful when you are trying to get started but it is not a substitute for taking advice or doing legal research.
- Always double-check the accuracy of any output.
 Generative AI tools can hallucinate, meaning they may invent legal cases and citations that don't exist.
- As well as verifying facts, it is important to check the currency of the output.
- Consider privacy and security issues, especially when dealing with sensitive data.
- Be aware of potential biases in any generated content.

According to <u>judicial guidance</u> (April 2025) users must take responsibility for any Al-generated material submitted in court.

In the recent case law, the courts have reiterated the professional duty to verify Al-generated research against authoritative sources before relying on it in legal submissions.

13. Commentary Sources

Commentary sources are useful because they help explain, interpret and contextualise primary legal materials like statutes and case law. They can help clarify complex areas of law, making them especially valuable for understanding how the law is applied in practice.

The availability of these works in public libraries is very limited. You are more likely to find them in academic libraries' collections, but access will be dependent on each library's admissions policy. See the section on Academic Libraries for more information.

13.1 Halsbury's Laws of England

Halsbury's Laws of England is an authoritative multi-volume encyclopedia of the law of England & Wales, arranged by subject.

It is a massive work, currently over 100 volumes, and is more likely to be found in an academic library (see <u>Academic Library Access</u>) although some larger public Ibraries may have this and you will find others have the odd volume on a specific topic so it is worth searching their catalogues (see <u>Public Libraries</u>).

13.2 Practitioner Texts

Practitioner texts are not easy to read and they are hugely expensive. The following titles, whilst being key works in civil, criminal and family law, are not going to be accessible to everyone, but it is good to have an awareness of their existence. All of the texts listed below are published annually.

17. Academic Library Access

Academic library access for non-members varies by institution but can include options for:

- · Local community access
- · Temporary passes
- Memberships
- · Access at the Librarian's discretion.

Conditions and Restrictions:

- Often access will be reference only, meaing you can consult materials on-site but not borrow them.
- Access to digital resources, including legal and academic databases, is generally not available to visitors due to licensing restrictions.
- Visitor use of computers and Wi-Fi is usually restricted or unavailable.
- Some libraries charge for visitor access but hardship exemptions may apply

Things to check before you visit to avoid delays or denied access:

- Contact the library ahead of your visit to check access terms and conditions.
- Registration forms and identification are often required, ensure you have ther relevant information.
- Some visitor access is restricted to consulting materials that can't be obtained elsewhere. In these instances be prepared to identify what you want to consult.
- Use the library's online catalogue to check their holdings
- Visitor access may be limited during busy periods, such as exam seasons.
- Not all branches or campuses are open to visitors. Make sure you know which location permits access.
